Agenda Item No.4

Proposal for amalgamation from M/s. Caliber Point Business Solutions Pvt. Ltd. to M/s. Hexaware Technologies Ltd. M/s. Caliber Point Business Solutions Pvt. Ltd. was issued LOA dated 12-3-2008 The first operational unit in MIHAN SEZ Information Technology (IT/ITES) IT enabled services and they have commenced operation from 1-12-2008. Caliber Point Business Solutins Pvt. Ltd was a fully owner subsidiary M/s. Hexaware Technologies Ltd, the Board of Directors M/s. Hexaware and M/s. Caliber Point Business Solutions Pvt. Ltd has decided to merge under the single brand name M/s. Hexaware Technologies Ltd. Accordingly an application for merger was filed before the Bombay High Court, the Bombay High Court approved the scheme of merger on 10th October, 2014 and put into

effect from 29th October, 2014 by Ministry of Company Affairs. As a result of which M/s. Caliber Point Business Solution Pvt. Ltd ceased to exist as separate entity and now will be part of M/s. Hexaware Technologies Ltd. Subsequent to this order all the communication and correspondence documents will be substit as Hexaware Technologies Ltd, the proposal was deliberate within purview of relevant provisions of SEZ Act,2005 and Rule, 2006 which states "Rule 19(2) SEZ Rule" Provided further approval committee may also approved change of entrepreneur of approved unit, if the incoming entrepreneur undertakes to take over assets and liabilities of the existing unit". After deliberation by the Members of the Committee, Development Commissioner approved the proposal with regard to amalgamation and the resultation change into entrepreneur.

Agenda Item No.5 : M/s. Beequerel Industries (P) Ltd.

They are into Hi-Tech Engineering Testing Facility for providing "Non destructive Testing & Engineering Services and Regulatory compliance assurance services". It was briefed to DC queries, the mode of activities the company proposed to undertakes in MIHAN SEZ. It was clarified that this activities of testing and inspection would be helpful for Industries like MRO and other Manufacturing Industry in MIHAN, requires 1 acre of land.
